## MINOR PARTICIPATION AGREEMENT, LIABILITY WAIVER, RELEASE OF CLAIMS, AND ARBITRATION AGREEMENT

PLEASE READ CAREFULLY. THIS AGREEMENT AFFECTS LEGAL RIGHTS.

### 1. PARTIES

Parent/Guardian enters this Agreement with Posey Acting Academy Inc., a Delaware corporation registered in California, on behalf of the minor participant and affirms legal authority to do so.

### 2. NATURE OF ACTIVITIES

Participant will engage in acting classes, rehearsals, physical movement, emotional expression, and on-camera performance activities. Activities may occur in person, online, via video conferencing platforms (including but not limited to Zoom), or in recorded environments, and all terms of this Agreement apply equally to such participation.

### 3. ASSUMPTION OF RISK

Parent/Guardian understands and voluntarily assumes all risks including physical injury, emotional distress, and unforeseen incidents on behalf of the minor.

### 4. RELEASE OF LIABILITY (INCLUDING NEGLIGENCE)

To the fullest extent permitted by California law, Parent/Guardian releases Posey Acting Academy Inc. and all affiliated parties from any claims including those arising from negligence, except for gross negligence or willful misconduct.

### 5. INDEMNIFICATION

Parent/Guardian agrees to indemnify and hold harmless the Company from any claims, damages, or legal fees arising from participation or actions of the minor.

### 6. MEDICAL AUTHORIZATION

Parent/Guardian authorizes emergency medical care if necessary and agrees to be financially responsible for any such treatment.

### 7. LIMITED MEDIA CONSENT

Parent/Guardian understands that occasional photos or videos of classes may be taken and used on social media or for promotional purposes. Parent/Guardian grants permission for such use on behalf of the minor. If Parent/Guardian later requests removal for reasonable cause, the Company will make reasonable efforts to accommodate such request. Parent/Guardian agrees to hold the Company harmless from any claims related to such media use.

### 8. CODE OF CONDUCT

Participant must follow all rules and behave appropriately. Violations may result in removal without refund.

### 9. PAYMENT TERMS

All payments are non-refundable unless otherwise stated.

### 10. ARBITRATION AGREEMENT

Any dispute shall be resolved by binding arbitration in Los Angeles County, California. Parent/Guardian waives jury trial and class action rights on behalf of themselves and the minor.

### 11. GOVERNING LAW

California law governs this Agreement.

### 12. SEVERABILITY

If any part is unenforceable, the remainder remains valid.
